No person shall be permitted to take away any and all Assets from the premises of the Gym. No person shall injure, damage, misuse or destroy any property of the Company or any of the Assets situated on the premises of the Gym.

The Company, the Gym, the Management and its employees will not be liable for any personal injury, death, and/or any other consequential misfortune/accident that arises in the course of training, for the loss, damage, or theft of personal property on its premises and for the unavailability of its equipment, facilities, and services at any time due to mechanical breakdown, fire, catastrophe, or any other unforeseen circumstance.
4. Only authorized personnel of the Company are permitted to offer training or related services of any kind in the Gym. Persons engaging the services of non-Fight G Pte Ltd personnel, providing personal training, or any other services within the premises will be subject to a permanent ban from the Gym and its premises and a legal claim against the person in the event of loss or earning suffered by the Company. The Company, the Gym, the Management and its employees will not be liable for any personal injury, death, and/or any other consequential misfortunate/accident that arises in the course of services engagement of non-Fight G Pte Ltd personnel.
5. The failure of the Company to enforce any respective rights at any time for any period shall not constitute as a waiver of such rights. The Management reserves the right to amend the above Terms and Conditions at any time at its own discretion.
6. Unless expressly provided to the contrary, a person who is not a party to this Membership Contract has no rights under the Contracts Act (Right of Third Parties), Chapter 53B of Singapore to enforce or enjoy the benefit of any term of this Membership Contract.
