### TERMS AND CONDITIONS

1. The Management reserves the right to accept or refuse the Attendee at its sole and absolute discretion.
2. The Attendee will abide by all rules and regulations of the Gym, including the House Rules, displayed in the Premises.
3. All equipment provided at the Gym and furniture, fixtures, fittings and other facilities on the Premises (collectively the 'Property') are wholly owned by the Management. Attendees who damage, misuse, destroy or remove any Property will be subjected to the provisions of Clause 4.
4. The Management reserves the right to take legal action against the Attendee and/or the Signee for the breach of any of the terms of this consent form. Both the Attendee and the Signee shall indemnify and keep indemnified the Management from and against: (a) all claims, demands, writs, summonses, actions, suits, proceedings, judgments, orders, decrees, damages, costs, losses and expenses of any nature whatsoever which the Management may suffer or incur in connection with the loss of life, personal injury and/or damage to Property arising from or out of any occurrence in, upon or at the Premises or the use of the Premises or any part thereof by the Attendee or by any of the Attendee's invitees; (b) all loss and damage to the Premises and all Property therein caused whether directly or indirectly by the Attendee or the Attendee's invitees; and (c) all the Management's legal cost and fees on a full indemnity basis incurred by the Management in consulting solicitors and/or in enforcing any provision of this consent form in the event of a breach by the Attendee of any of the provisions hereof.
5. The Management and its employee, representatives and agents will not be liable for any personal injury, accident, death, loss, damage or theft on the Premises whatsoever suffered by the Attendee or any other person; or if the Property or the Premises are made unavailable as a result of any event or circumstance, regardless of whether it was foreseeable, so as to render the Property or Premises unfit for use. Both Signee and the Attendee shall not hold the Management liable for any of the foregoing events. If the Management decides that Property or Premises are unavailable for the Attendee's use for the trial class, the Management shall endeavour but not be obliged to notify the Attendee of the booking cancellation. The Attendee may reschedule a complimentary trial class."
